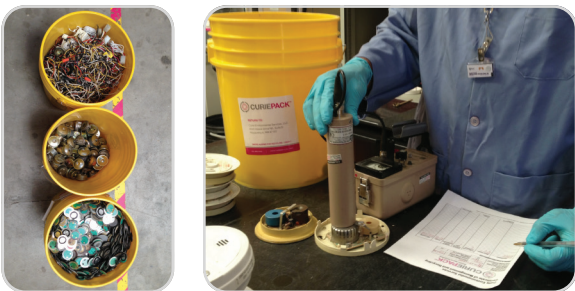
## Licensed Brokerage & Disposal
